### IMPORTANT INFORMATION

(Excerpt from the League of Women Voters)

- Texas has open primaries, which means all Texas voters can participate in either the Republican or Democratic primaries.
- Voting in one party's primary election does NOT commit you to vote for a particular party or candidate in the November General Election. You can still vote for any candidate of your choice, regardless of party, in the General Election.
- Since many districts in Texas heavily favor one party over the other, the primary elections often determine the winner of the General Election! Even if you do not strongly identify with any political party, you can and should carefully consider the candidate choices and participate in one of the primaries.
